

# Off Licence

Section 17 to 20, 64 and 135, Sale and Supply of Alcohol Act 2012



007/OFF/81/2019

Section 40 of the Act applies to this licence.

Pursuant to the Sale and Supply of Alcohol Act 2012 (the Act), **Boutique Connection Limited** (the licensee) is authorised to sell alcohol from (but not on) the premises situated at **29 Hardens Lane Paremoremo 0632**, and known as **www.boutiqueconnection.co.nz**, and deliver it somewhere else.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

## CONDITIONS

This licence is subject to the following conditions:

- (a) No alcohol sold is to be delivered on Good Friday, Easter Sunday, Christmas Day, or before 1pm on Anzac Day; or at any time after 11pm on any day and before 6am on the next day.
- (b) **The remote sale of alcohol may be made at any time on any day, however the days and hours within which alcohol that has been sold may be delivered is restricted, as set out in condition (a), above.**
- (c) The whole of the premises is **Undesignated**.

## DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force—

- (a) either—
  - (i) until the close of the period for which it was last renewed; or
  - (ii) if it has never been renewed, until the close of the period of 12 months after the day it was issued; but
- (b) if an application for the renewal of the licence is duly made before the licence would otherwise expire, either—
  - (i) until the close of the period of 3 years after the period for which it was last renewed; or
  - (ii) if it has never been renewed, until the close of the period of 4 years after the day it was issued.

**This licence expires the close of 14 August 2020 unless renewed.**

**DECISION**

***Introduction***

[1] I have before me an application for a new off-licence in respect of premises situated at the above address. The nature of the business is a remote sales and the hours sought are as set out below.

[2] A report on the application was received from an Inspector, the Medical Officer of Health and the Police offering no objection.

[3] The application was duly advertised and did not attract any public objection.

***Committee’s Decision and Reasons***

[4] I am satisfied as to the matters which I must have regard as set out in s.105 of the Act, and I am satisfied that the application meets the purpose and object of the Act. Accordingly, I grant the applicant an off licence. The licence may issue upon payment of any outstanding fee.

[5] I refer any party who wishes to appeal this decision or part of this decision to sections 154 through to 158 of the Act.

***Conditions***

[6] The conditions to be attached to the licence are as follows:

- (a) No alcohol sold is to be delivered on Good Friday, Easter Sunday, Christmas Day, or before 1pm on Anzac Day; or at any time after 11pm on any day and before 6am on the next day.
- (b) The remote sale of alcohol may be made at any time on any day, however the days and hours within which alcohol that has been sold may be delivered is restricted, as set out in condition (a) above.
- (c) The whole of the premises is undesignated.
